2ND READING/PUBLIC HEARING:

- ORDINANCE 2022-11 Establishment of Base Salaries for Year 2022
ORDINANCE 2022-12 Establishment of Base Salaries for Year 2022- Police and Fire

Mayor Chung stated that Resolution #2022-278, Authorization of Salary or Compensation for Employees for 2022, needed to be tabled. He also stated that Off Consent Resolution #2022-293 was to be amended to "Authorization of Police Promotion to Chief of Police and Approving Contract." The Borough Attorney stated that the 2nd Reading for the Salary Ordinances needed to be tabled because they were initially advertised for a hearing in November, but the November meeting and Special Meetings did not take place due to the lack of a quorum. The hearing for these Ordinances needed to be readvertised 7 days prior to the meeting of the hearing. They were not advertised for the December 22nd meeting, and therefore the Ordinances could not be acted upon. The Ordinances would have to be reintroduced on a first reading because when the calendar year ends, the life of the Ordinances would have to start over. Councilwoman Pirrera asked how that would affect the money. Mr. Schettino stated that if the Ordinances were adopted this year, the salaries would have been taken out of this year's budget. However, since they would not be adopted this year, it would go into next year's budget. Next year's budget would have to fund the salary increases for 2022 and 2023. Councilwoman Jang asked about budgeting the salary increases. Mr. Schettino answered that the budget can include two increases in one year. He also explained that the surplus could be used to offset the tax increase. For example, if the tax increase were to be 10 points, and there was money in surplus, you could use the surplus to fund the entire budget to reduce the tax levy.

Mayor Chung said that Resolution #2022-295, Authorization of D.P.W Promotion, had to be tabled because the Borough Administrator was asked to provide information as to what the details were for the promotions (positions, increased salaries, job descriptions), and these were not provided. Mr. Schettino stated that there needed to be a motion and second for all the items mentioned.

Councilman Jang made a motion to table Resolutions #2022-278 and #2022-295 and Ordinances #2022-11 and #2022-12 and amend Resolution #2022-293 to include approval of contract. Councilman Min seconded the motion. The motion carried on a roll call vote. Councilwoman Pirrera recused herself from police matters. All present in favor; none opposed.

COUNCIL REPORTS:

There were no Council reports.

PUBLIC PARTICIPATION:

Councilwoman Jang made a motion to open to the public. Councilman Min seconded. The motion carried. All present in favor by voice vote; none opposed.

Susan Brauer (50 Henry Ave) asked for clarification on Resolutions #2022-293 & #2022-294. Mayor Chung explained that Resolutions #2022-293 was for the promotion and approving the contract for the Chief.

Youbong Won-Yoon inquired about Resolution #2022-278. Mayor Chung answered that it was tabled. She asked about Resolution #2022-291. Mr. Schettino explained the Council needed to approve the updated tort claims form. She asked about Resolution #2022-283. Mr. Schettino answered that this Resolution was for all retirees and for every town in the State of NJ. She asked if holiday free parking would happen. Mr. Schettino said it will be approved tonight. She asked about Resolutions #2022-293 & #2022-294. She wanted to know the criteria for police promotions. Mr. Schettino answered that the Mayor and Council voted to post for the position and conduct interviews. The Police Committee, which consisted of the Mayor and Councilman Park, conducted interviews and reviewed Officer-in-Charge Espino's performance. He had been the "Acting Chief" for the past six months, and the Police Committee felt that he was doing a good job so they recommended him to the Council to be promoted. She said that there was an outstanding lawsuit. Mr. Schettino said this would be resolved tonight.

Soo Chung (237 E. Central Blvd) wanted an explanation regarding #2022-285. Mr. Schettino explained it was a shared service agreement with Northwest Bergen County Utilities Authority to use their camera equipment. She also commented on the Police promotion. Mr. Schettino stated there was no prohibition against someone being involved with a lawsuit and being promoted. He stated that this settlement was mediated by a Federal Court Judge who recommended the settlement and the insurance company attorney. Mr. Schettino said that if someone made a viable complaint and if a promotion were not given to that employee due to the complaint that was filed, that would be considered retaliation and would create another lawsuit.

Neris Papoter (444 Glen Ave) questioned Resolution #2022-293 & #2022-294. She asked about the requirements and what other candidates were interviewed. Mayor Chung explained that the position was posted and everyone that had signed up were given an opportunity to interview. For the Chief's position, there was only one person who signed up. They had interviewed Espino and felt that he met the criteria and qualifications with his experience and all the trainings that he had gone through his years of service in Palisades Park. Mr. Schettino answered that because there was no Police Chief, Captain Espino had 6 months to prove himself. He said this was more of a process than anywhere in the State of NJ because most times, they do not serve as the head of the department before they are promoted.

There being no further business to come before the Mayor and Council, Councilman Min made a motion to close to the public and adjourn. Councilwoman Jang seconded. All present in favor by voice vote; none opposed.

WHEREAS, lung cancer is the leading cause of cancer death among men and women in the United States accounting for more deaths than colon cancer, breast cancer, and prostate cancer combined; (1)(2)

WHEREAS, the 5-year survival rate for localized lung cancer is ~60%, yet only ~24% of lung cancers are diagnosed at this stage; (1)

WHEREAS, screening for lung cancer for high-risk individuals using low-dose computed tomography can lead to the earlier detection of lung cancer and save lives, reducing the mortality by 20% when compared to screening by chest x-ray in the National Lung Screening Trial (3) and reducing the risk of death at 10 years by 24% in men and 33% in women as demonstrated by another large randomized trial; (4)

WHEREAS, funding for lung cancer research trails far behind funding for research of many other cancers, and additional research is needed in early diagnosis, screening, and treatment for lung cancer as well as in lung cancer affecting women and lung cancer health disparities;

WHEREAS, lung cancer incidence is decreasing twice as fast in men as it is in women, each year more women die from lung cancer than breast cancer and by 2035, more women will die from lung cancer than men; (6,7)

WHEREAS, African Americans have the highest lung cancer incidence and mortality of all races, and disparities in lung cancer screening, diagnosis, treatment, and mortality are well characterized among African Americans and other racial minorities. (8)


WHEREAS, lung cancer in never smokers is the 7th leading cause of cancer-related death and accounts for 17,000-26,000 deaths in the US every year (7), 60-70% of never smokers diagnosed with lung cancer are women (9,10), and the proportion of lung cancers diagnosed in never smokers is increasing in the US; (10,11)

WHEREAS, organizations such as the American Lung Cancer Screening Initiative and Women's Lung Cancer Forum, are committed to educating about lung cancer and lung cancer screening and working to increase lung cancer screening rates.

NOW, THEREFORE, BE IT RESOLVED, the Mayor and Council of the Borough of Palisades Park hereby proclaim November 2022 as Lung Cancer Awareness Month in the Borough of Palisades Park; and



WHEREAS, in accord with the Palisades Park Police Department Organizational Chart, there is presently a vacancy for the rank of Captain; and


WHEREAS, Lieutenant John Gasparovich has met all the qualifications necessary for the position of Captain in the Palisades Park Department; and
